

WHEREAS the several blocks of Maori freehold land set out in the First Schedule hereto containing together an area of 03 perches are held under roods separate titles as set out in the said Schedule AND WHEREAS upon hearing an application for an order cancelling the said titles and substituting therefor one title to the whole of the land THE COURT is satisfied that the whole of the land comprised in the said titles could be more conveniently worked or dealt with if it were held in common ownership under one title IT IS HEREBY ORDERED that the several titles as set out in the said First Schedule BE AND THE SAME ARE HEREBY CANCELLED and a new title for the whole of the land comprised in the said several titles containing 937 acres 03 perches, more or less, as the same is more 3 roods particularly delineated on the plan annexed hereto is HEREBY CONSTITUTED in substitution for the said several titles, the land in such titles to be hereafter known as HIWARAU C being Maori freehold land and the said land is HEREBY VESTED in the persons whose names are set out in the Second Schedule hereto for an estate in fee simple as tenants in common in the relative shares shown opposite their respective names AND IT IS FURTHER ORDERED pursuant to section 34 (10) of the said Act, that this order do issue FORTHWITH from the office of the Court.
