Sir, Salutations to you.

We are applying to you to have a portion
of our block at Te Kaiti (called) Oamara
Rehau, No 7 in the Kaiti. The portion
we are applying for is that which has
gone into the award to Ngatinihere,
^{into} Oamara No 5. I am not clear as to
the reason of Judge Wilson, the judge of this
court, giving it; we are not clear about the
reason. The evidence of Manihera Maiti,
witness for the case of Ngatinihere, was
good. We therefore apply to you to give
effect to our application for a rehearing of
a portion of our block Oamara No 5. We
are not clear about the kind of judgment
given by this court. It differs (from others)
to give the award in favour of his old
friends. He did not consider the right or
the wrong of the witness, since he gave to
Manihera Maiti a portion of our land.
Manihera Maiti is an old friend of his, and
it was Maiti that gave the Kaiti Block
