Mr. Substitution to you.
We are applying to you to have a portion
of our block at Il Maiki (called) Damam
Reheard, No. 7 in the Tahiti. The portion
we are applying for is that which has
gone into the award to Ngatimahere,
~~and~~ Damam No. 5. I am not clear as to
the reason of Judge Wilson, the former of the
Court giving it; we are not clear about the
reason. The evidence of Manihera Maiki,
witness for the case of Ngatimahere, was
good. We therefore apply to you to give
effect to our application for a rehearing of
a portion of our block Damam No. 7. We
are not clear about the kind of judgment
given by this Court. It differs (from others)
He gave the award in favour of his old
friends. He did not consider the right or
the wrong of the instance, since he gave to
Manihera Maiki a portion of our land.
Manihera Maiki is an old friend of his, and
it was Maiki that gave the block.
