The reasons for our application for the  
rehearing of that land are these - Our ancestors

Agent for the case of Ngatimahere, Taupo.

These are the ancestors:

To Rangitau  
Te Rangitaukapito  
Te Rangitauamana  
Tamaire  
Tomatau  
Kavataukahaia

These are our ancestors on account of whom  
we apply to have Parau N. 5-reheard.  
Also on account of the lists of names given  
by us to the agents of that case, namely  
to Taupo and Matiu Mahonea, that they  
should hand them into the court. They did  
not hand them in, but tore them up.
