This is an application of ours to
you for the rehearing of Oamaru No. 5,
in the district of Opetiki.

The reasons for our application for the
rehearing of that land are these - Our ancestors
are the same as those mentioned by the
Agent for the case of Ngatingahere, Tawhiti.
They continued occupation of that land.
These are the ancestors: -

- To Kariutauri
- To Huhitau Kapiti
- To Huhitau manua
- Tamdaue
- Tomatia
- Kavata Kahia

These are our ancestors on account of whom
we apply to have Oamaru No. 5 reheard.

Also on account of the lists of names given
by us to the agents of that case, namely
to Tawhiti and Matiu Mahona, that they
should hand them into the Court. They did
not hand them in, but tore them up.
