

Descriptions of boundaries of subdivisions of Hiwarau B No.4

Hiwarau B No.4A

32a.2r.00p.

Boundaries. Being all the Northern end of the 98a.1r.35p. part bounded on the South by a line (at right angles to Eastern boundary) from block boundary to river.

Hiwarau B No.4B

20 acres

Boundaries. To be South of B 4A and bounded on the South by a line parallel to South boundary of B 4A.

Hiwarau B No.4C

25a.3r.35p.

Boundaries. To be South of B 4B and bounded on South by a line parallel to South boundary of B 4B.

Hiwarau B No.4D

20 acres

Boundaries. Being balance of 98a.1r.35p. lying to the South of B 4C.

Hiwarau B No.4E

41a.3r.00p.

Boundaries. Being that part of the 100a.2r.00p. and adjoining part (coloured green on plan) B3. Bounded on South by a line from eastern boundary to river and at such a distance from and parallel to South boundary of B3 as will enclose required area.

Hiwarau B No.4F

29a.1r.20p.

Boundaries. Being part of 100a.2r.00p. to the South of B 4E and North of a line parallel to South boundary of B 4E.

Hiwarau B No.4G

29a.1r.20p.

Boundaries. Being remaining part of 100a.2r.00p. to the South of B 4F.

Right of way from road to B 4E to be provided for access thereto over F and G along ~~Nukuhou~~ Nukuhou river or in most suitable part as surveyor deems advisable.

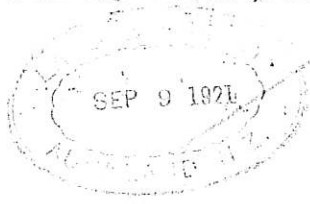
