[or vesting in his Majesty a defined portion of the said land in fee-simple, in satisfaction and discharge of such cost of survey].

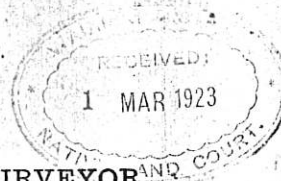
