1. I have read the order-in-Council of 10/10/1910 concerning upon the main hand Cent (pursuant to Section 25 of the Native Land Act 1909) extended jurisdiction to ascertain who are the persons entitled to the above land and in what shares and proportions. The vacant land was one of 19 lands listed in the schedule to that O-in-C.

2. As I understand the position no application has been made to the main hand Cent in terms of the ^{order-in-Council} application; or if one was made it cannot now be traced or its fate discovered. It seems therefore that there is no current application entant the Cent, unheard or part heard.

3. If this is so then I am of the view that consequent upon the ^{the very latest point of time} repeal of the Native Land Act 1909 the order-in-Council is to be deemed exhausted or spent as a matter of law.

3. maybe you could cause search to be made of the other lands in the schedule & get into the earlier proceedings; the minutes may throw some light on Waiotahi 292?
