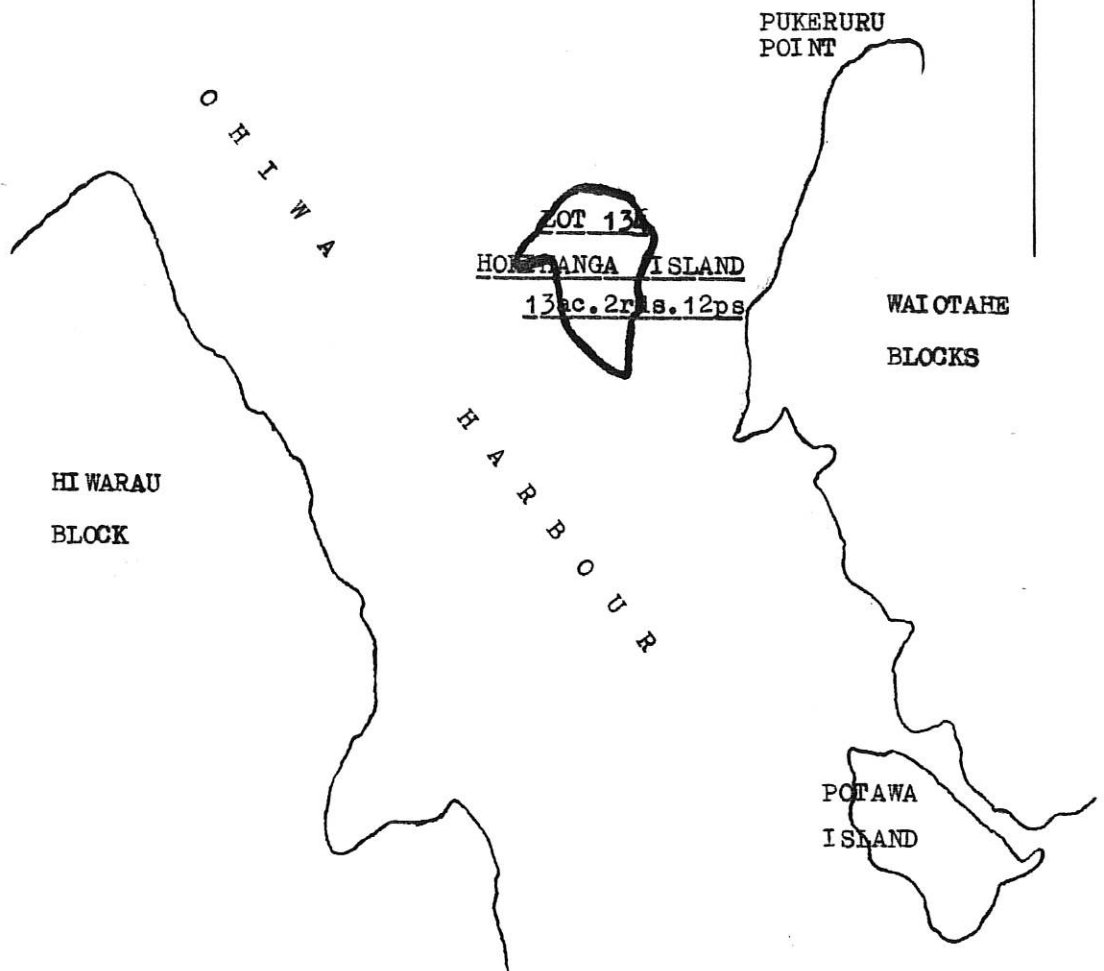

*Setting Apart Maori Freehold Land as a Maori Reservation*

PURSUANT to section 439 of the Maori Affairs Act 1953, the Maori freehold land described in the Schedule hereto is hereby set apart as a Maori reservation for the purpose of a burial ground and as a place of historic and scenic interest for the common use and benefit of Upokorehe and other Maori peoples of the district generally.
